Introduction

This Statement describes the types of information we may collect from you or that you may provide when you visit the website <u>www.puchkofinancial.com</u> and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This Statement applies to information we collect:

- On this Website.
- In email, text, and other electronic messages between you and this Website.
- Through mobile and desktop applications you download from this Website, which provide dedicated nonbrowser-based interaction between you and this Website.
- When you interact with our advertising and applications on third-party websites and services, if those applications or advertising include links to this Statement.

It does not apply to information collected by:

- Us offline or through any other means, including on any other website operated by Company or any third party; or
- Any third party, including through any application or content (including advertising) that may link to or be accessible from or on the Website

Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Website, including information:

- By which you may be personally identified, such as name, postal address, e-mail address, telephone number, or any other information ("**personal information**");
- That is about you but individually does not identify you, and/or
- About your internet connection, the equipment you use to access our Website, and usage details.

We collect this information:

- Directly from you when you provide it to us.

Information You Provide to Us

The information we collect on or through our Website may include:

- Your search queries on the Website.

Information We Collect Through Automatic Data Collection Technologies

We may disclose personal information that we collect or you provide as described in this privacy Statement:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Puchko Financial Associates, Inc.'s assets, whether

as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by Puchko Financial Associates, Inc. about our Website users is among the assets transferred.

- To third parties to market their products or services to you if you have consented to/not opted out of these disclosures.
- To fulfill the purpose for which you provide it. For example, if you give us an email address to use the "email a friend" feature of our Website, we will transmit the contents of that email and your email address to the recipients.
- For any other purpose disclosed by us when you provide the information.
- With your consent.

We may also disclose your personal information:
